**Entries are invited for the forthcoming Sale to be held within
BORDERWAY MART, CARLISLE CA1 2RS**

Entries must be from MV accredited flocks.

Scrapie Genotyping – please refer to previous Society correspondence. All sheep entered for the sale have to be either from a scrapie monitored flock or **MUST** be individually genotyped. Only ARR/ARR sheep can be offered for sale.

Important - Recorded Flocks – vendors must tick the relevant box if they wish to have the Signet Sheepbreeder Recording information stated in the sale catalogue.

The sale yard will be open from 2pm on Thursday 5th August. A limited amount of bedding straw will be provided for the pens.

All sheep must be penned by 8.30am on Friday 6th August for the veterinary inspection.

The sale start time will be determined when entries have been received and the order of sale will be:

	Shearling Ewes	Ewe Lambs
Aged Rams	Shearling Rams	Ram Lambs

Please Note (Female Entries), these are to be restricted to a maximum of 5 Gimmer Shearlings and/or 5 Ewe Lambs per breeder.

The entry fee per animal is £15 + VAT (£18.00) and is non-refundable.

Commission. All sheep will be sold in guineas (105 pence) and a commission of 5.25% will be charged on the sale price. The society sale levy is an additional 1½ %.

Substitutes. Up to **TWO** substitutes will be allowed per vendor and these must be notified to Carlisle not less than 3 days before the event i.e. no later than 5pm on Tuesday 3rd August. Only substitutes notified in this way will be eligible for entry to the sale.

Any sheep that have previously been rejected at a Society Sale cannot be entered for this sale.
