CONDITIONS OF ENTRY AND GENERAL SALE BYE-LAWS

- 1. Entries must be from MV accredited flocks.**
- 2. Scrapie Genotyping** – please refer to previous Society correspondence. All sheep entered for the sale have to be either from a scrapie monitored flock or MUST be individually genotyped. Only ARR/ARR sheep can be offered for sale.
- 3. Recorded Flocks** – vendors must tick the relevant box if they wish to have the Signet Sheep breeder Recording information stated in the sale catalogue.
- 4. All sheep MUST be penned by 8.30am on Friday 5th August** for the veterinary inspection.

4a. The show classes are as follows:

For Show purposes ONE animal per vendor per class (class 5 one pair)

Class 1 Best Shearling Ewe

Class 2 Best Ewe Lamb

Class 3 Best Shearling Ram

Class 4 Best Single Lamb Ram, trimmed or untrimmed

Class 5 Best Pair of Lamb Rams

N.B - Only the winning pair can have one or both lambs forward in class 7 ALSO

No Lamb can be shown in more than one class

Class 6 Best Female in the Show

Class 7 Best Male in the Show

Class 8 Overall Champion

Class 9 Trophy awarded for the 'Top Priced' sheep from a Northern Counties member.
(This will be presented at our areas Flock View day)

5. **The sale start time will be determined when entries have been received and the order of sale will be: Shearling Ewes**
 - Ewe Lambs**
 - Aged Rams**
 - Shearling Rams**
 - Ram Lambs**
6. **Female entries will be restricted to a maximum of 5 Gimmer Shearlings and/or 5 Ewe Lambs per breeder.**
7. All males entered must be Birth Notified and Females entered must be Fully Registered with the Society prior to submission of entry
8. **The entry fee per animal is £15 + VAT (£18.00) and is non-refundable.**
9. **Commission.** All sheep will be sold in guineas (105 pence) and a commission of 5.25% will be charged on the sale price. The society sale levy is an additional 1½ %.
10. **Substitutes:** Up to Two substitutes will be allowed per vendor and these must be notified to Carlisle not less than 3 days before the event i.e. no later than 5pm on Tuesday 2nd August. Only substitutes notified in this way will be eligible for entry to the sale.
11. Any sheep that have previously been rejected at a Society Sale cannot be entered for this sale.
12. **Outstanding Balances:** Please note that the Society Council have approved that no sheep will be allowed access to any Society Sale if an outstanding balance exists with the Society. All cheque payments must be received by the Society office by Monday 11th July for inclusion in this sale. If you are unsure of your current accounts status please call Tel: 02825 632342.
