  days in advance of your account being debited or as otherwise agreed. If you request the Suffolk Sheep Society to collect a
  payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by the Suffolk Sheep Society or your Bank or Building Society, you are
  entitled to a full and immediate refund of the amount paid from your Bank or Building society
  - If you received a refund you are not entitled to, you must pay it back when the Suffolk Sheep Society asks you to
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
