Direct Debit

All new members must pay by direct debit. Please enclose your completed direct debit form with your application form.

Membership Benefits

Youth and Young Adult members are entitled to 2 free Female Registrations per year for their first three years after joining or until they graduate to Full Adult Membership, and 50% off a Male Registration if registered within six months of joining.

Unregistered Suffolks

Do you own purebred Suffolks that have not been registered and have previously not been eligible for your pedigree flock?

If the answer is yes and

- 1. You use a registered ram
- 2. Your flock is inspected by a Society Inspector

then the progeny of all approved ewes is considered pure and eligible for registration in the Flock Book

You can also grade up to registered status by using registered Suffolk rams and having the offspring included in a supplementary register until they are 7/8ths pedigree, at which point they can be entered in the main section of the Flock Book. Please contact the Ballymena office for further details.

Once your flock is registered, your Suffolks are eligible for:

- Entry in Society Sales
- Entry is classes for registered breeders at Shows
- Inclusion in Society recording schemes

The Direct Debit Guarantee



- This Guarantee is offered by all banks and building societies that accept instructions to pay by Direct Debit.
- If there are any changes to the amount, date or frequency of your Direct Debit the Suffolk Sheep Society will notify you 14 working
 days in advance of your account being debited or as otherwise agreed. If you request the Suffolk Sheep Society to collect a
 payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by the Suffolk Sheep Society or your Bank or Building Society, you are entitled to a full and immediate refund of the amount paid from your Bank or Building society
 - If you received a refund you are not entitled to, you must pay it back when the Suffolk Sheep Society asks you to
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
